2. Loan Document Identification and Purpose

Answer:

The Promissory Note is the borrower's unconditional promise to repay the loan amount, plus interest, according to a specific schedule. It is the borrower's binding legal obligation. The Promissory Note typically does **not** require notarization. However, it is a critical document that must be signed correctly. The Notary Signing Agent should ensure the borrower understands that signing this document creates their legal duty to repay the loan.

Sample Question:

Which document requires notarization and creates a lien on the property?

Answer:

The Deed of Trust (in many states) or

the Mortgage (in other states) requires notarization. This document is recorded in the county land records and creates a security interest in the property. If the borrower fails to repay the loan, the lender can foreclose on the property. Because this document transfers an interest in real property, it must be notarized to be recorded. The borrower (trustor) is the one who signs and must be notarized.

Sample Question:

What is the Closing Disclosure, and what is its purpose?

Answer:

The Closing Disclosure (CD) is a five-page document that summarizes the final terms of the loan, including the loan amount, interest rate, monthly payment, closing costs, and other fees. The

borrower must receive this document at least three business days before closing. The Notary Signing Agent should guide the borrower through the CD, page by page, to confirm that the terms match what was expected. The CD does **not** require notarization, but it is the most important document for the borrower to review carefully.

3. The Signing Ceremony Procedure

This section tests your ability to manage the signing appointment professionally and efficiently. It covers everything from

setting up the table to handling signatures and initials.

Sample Question:

Where should the borrower initial on a loan document, and why is this important?

Answer:

The borrower should initial in the specific areas indicated, often at the bottom of each page or next to certain disclosures. Initials confirm that the borrower has seen and acknowledged specific provisions, such as adjustable rate riders, escrow waivers, or other important terms. The Notary Signing Agent should point out where initials are required and ensure the borrower initials in the correct, often pre-marked, locations. Missing initials is one of the most common reasons for a document

package to be rejected.

What should you do if a borrower asks you for legal advice about a loan document?

You must politely and clearly state that you are prohibited from giving legal advice. You can explain that you are a Notary Signing Agent, not an attorney, and that you cannot interpret the meaning or consequences of any document. However, you can read the document verbatim if the borrower asks. If the borrower has a substantive legal question, you should advise them to consult with their loan officer, escrow officer, or a real estate attorney. This boundary is critical to avoid the unauthorized practice of law.

How should you handle a situation where a borrower wants to sign a document with a different name than what appears on their identification?

This is a red flag for potential fraud. You should not proceed with the notarization. First, ask the borrower why the name is different. In many cases, the borrower must sign using the name on their identification. 4. Fraud Prevention and Ethical Considerations

If the borrower indicates they are being forced, or if you see obvious signs of coercion, you must stop the signing immediately and refuse to perform the notarization. You should then report your concerns to the hiring signing service or title company. Your integrity is more important than

completing a signing.

5. The Loan Process and Role of the Signing Agent

Understanding the broader loan process helps you answer questions about your specific role and responsibilities.

Sample Question:

What is the difference between a Refinance and a Purchase transaction?

Answer:

In a refinance, the borrower already

owns the property and is simply replacing their existing loan with a new one. The borrower meets with the Notary Signing Agent to sign the new loan documents. In a purchase transaction, the borrower is buying the property from a seller. This involves a more complex document package, including the deed from the seller to the buyer. In a purchase, all parties (buyer and seller) may need to sign documents, and the notarization requirements are different. The Notary Signing Agent must be especially careful with purchase transactions because multiple signers and multiple notarizations are often involved.

Sample Question:

What should you do with the signed document package after the signing is

complete?

Answer:

The instructions from the signing service or title company will specify how to return the documents. Typically, you will scan and upload the entire package digitally using a secure portal. Some documents may need to be returned via overnight courier. It is critical to follow the instructions precisely and return the package promptly. You must never keep copies of the signed documents for your own records unless specifically instructed to do so, as the documents contain sensitive personal and financial information. Your responsibility ends when the package is securely returned.
