Secure Comprehensive Insurance

Insurance is non-negotiable. The bare minimum includes:

- **General Liability Insurance:** Covers property damage and bodily injury to third parties. Essential for

protecting your business when you are on client sites.

- **Workers' Compensation Insurance:** Required in most states if you have employees. It covers medical costs and lost wages if a worker is injured on the job.
- **Commercial Auto Insurance:** For vehicles used for business purposes.
- **Tools and Equipment Insurance:** Protects your investment in case of theft or damage.

Many general contractors also require subcontractors to have their own

insurance. Work with an insurance agent who understands the construction industry to tailor a policy that fits your risks.

Register for Taxes and Get an EIN

An Employer Identification Number (EIN) from the IRS is necessary for paying business taxes, hiring employees, and opening a business bank account. Even if you are a sole proprietor, an EIN keeps your personal Social Security number off invoices and tax forms. Register online in minutes.

Also understand your

state and local tax obligations, including sales tax on materials and self-employment tax. Proper bookkeeping from the start prevents headaches during tax season.
