However, the CDL test is also available in Chinese at certain DMV offices.

You will take the test on a touchscreen computer at the DMV office. The interface allows you to select your answer and review questions before submitting. If you prefer, a paper version can be provided upon request. The entire test is untimed, so you can take as long as you need to read each question carefully.

What Happens If You Fail the Test?

If you do not pass the **California DMV written test in Chinese** on your first attempt, do not worry. You can retake the test the same day, but only after waiting a short period. Some offices allow immediate retakes, while others may ask you to come back the next day. Check with your local DMV for their specific policy. There is no limit to the number of times you can retake the written test within a certain period, but each retake may require a small fee. Use the experience as a learning opportunity. Review the questions you missed and study those topics more thoroughly before trying again.
