PARTS 210 AND 211: CURRENT GOOD MANUFACTURING PRACTICE (CGMP) FOR DRUG PRODUCTS

PARTS 1300-1399: CONTROLLED SUBSTANCES (DEA)

Chapter II of Title 21 contains regulations enforced by the Drug Enforcement Administration. These parts govern the

manufacturing, distributing, dispensing, and prescribing of controlled substances (e.g., opioids, stimulants, depressants). Pharmacists, physicians, and researchers must be familiar with registration requirements, security controls, and recordkeeping obligations under these parts.
