File online through the USPTO’s Patent Center or using the electronic filing system. Pay the required filing fees (which vary based on entity size: micro, small, or large). For those wondering **how to patent a product** on a budget, micro-entity status offers significant fee reductions.

Step 6: Respond to Office Actions and Examiner Communications

After filing, a patent examiner reviews your application. They will issue an Office Action, which is a written communication indicating rejections, objections, or requirements.
