Limitations and Prohibitions

While powerful, a Louisiana notary is not an attorney. The notary cannot give legal advice, represent clients in court, or prepare pleadings (with very narrow

exceptions). The line between drafting a legal document (which a notary may do under the “blank form” doctrine) and practicing law (which requires a law license) is a constant source of debate and is an essential topic in **Louisiana Notarial Law And Practice**.
