## UNDERSTANDING OSMOSIS: THE KEY TO PLANT CELL BEHAVIOR

most land plants and is generally not beneficial because the cell lacks the mechanical support of turgor. Water movement is equal into and out of the cell.

# The Hypertonic Solution: Plasmolysis

This is the dangerous opposite. The external solution is concentrated (high solute, low water). Water leaves the cell. As the cell loses water, the plasma membrane pulls away from the cell wall. This process is called plasmolysis. The plant wilts. If severe or prolonged, it can

lead to cell death. This is why salt water kills most land plants. When **a plant cell in a hypotonic solution** experiences the opposite, it suffers plasmolysis.

After a summer thunderstorm, you may notice that your garden looks revitalized. Plants that were slightly wilted from the

afternoon heat become upright and perky. This is because the rainwater is a hypotonic solution relative to the soil and the plant cells. Water rushes into the roots and leaves, restoring turgor pressure throughout the plant.

## 4. Fertilizer Burn

This is a cautionary tale. If a gardener applies too much chemical fertilizer, the soil solution can become hypertonic. Instead of water entering the roots, it is pulled out. The plant cells begin to plasmolyze, leading to wilting, browning, and plant death. This is why it is critical to follow fertilizer instructions and to water thoroughly to maintain a healthy, hypotonic root environment.

### THE ROLE OF THE VACUOLE

---

The central vacuole plays a starring role in this story. In a mature plant cell, the vacuole takes up 80 to 90 percent of the cell's volume. It stores water, nutrients, and wastes.
