acceptable rate of return (MARR), which is often the organization's cost of capital. Rate of return analysis is popular because it yields a percentage that can be easily compared with other investment opportunities.

Benefit-Cost Ratio

Commonly used in public sector projects, the benefit-cost ratio compares the present value of benefits to the present value of costs. A ratio greater than 1.0 indicates that benefits outweigh costs. This method is particularly valuable when projects have significant social or environmental

Payback Period
