Domain: $(-\infty, 5) \cup (5, \infty)$.

4. **Square root**

function: $f(x) = \sqrt{x + 3}$. Set the radicand ≥ 0 : $x + 3 \geq 0$, so $x \geq -3$. Domain: $[-3, \infty)$.

If the domain is the "input," then the **range** is the "output." the graph of $f(x) = \sin(x)$. The sine wave repeats infinitely in both directions along the x-axis, so its domain is all real numbers. However, the sine wave never goes above 1 or below -1, so its range is $[-1, 1]$. This visual approach makes it much easier to see the relationship between inputs and outputs.

When using graphs, pay attention to **asymptotes** and **holes**. A vertical asymptote indicates a value excluded from the domain, while a horizontal asymptote may suggest a limit on the range. Holes in the graph (points where the function is undefined) also affect the domain.
