- **Trial Periods:** A short initial period, such as two weeks or one month, during which both parties can evaluate the dynamic.
- **Ongoing Renewable Terms:** A contract that automatically renews unless either party gives notice of intent to renegotiate or terminate.
- **Scene-Specific Contracts:** An agreement that applies only to a single session or event, with clear start and end times.

## Scope of Authority

This section defines how much authority the Dominant holds over the submissive. It may be limited to specific areas such as sexual activities, daily routines, or appearance, or it may be broader, encompassing lifestyle decisions like diet, sleep schedules, and social engagements. It is crucial to be specific about what the Dominant can and cannot control. For example, a contract might state that the Dominant has authority over the submissive's clothing choices during scenes but not at their workplace.
