If you're a Premium member or use Sales Navigator, cancel your subscription first to avoid being charged after your profile is removed.

5. **Review Your LinkedIn Recruiter Account:** If you have a Recruiter seat, deletion of your personal profile will also remove your Recruiter access. Coordinate with your organization's admin if needed.

REMOVE A LINKEDIN PROFILE (DESKTOP)

Most users prefer to perform this action on a computer due to the clearer navigation. Follow these precise steps to permanently delete your LinkedIn profile via desktop.

Step 1: Log In and Access Settings

Go to LinkedIn.com and log in with the credentials you wish to delete. In the top right corner, click your profile picture or the "Me" icon. Select

Step 2: Navigate to Account Managem ent

On the *Settings & Privacy* page, look for the **Account** tab on the left sidebar. Click it. Under "*Account management*", you'll see options including "**Change your password,**" "**Close your LinkedIn account,**" and others. Select "**Closing your LinkedIn account**" to proceed with the

removal process.

Step 3: Choose "Close Account"

LinkedIn will display information about what happens when you close your account. Read this carefully. If you still want to proceed, click the blue button that says "**Close account.**" You may be asked to provide a reason for leaving. Choose an appropriate option or select "*Other*" and type briefly.

To confirm this is not an accidental click, LinkedIn will prompt you to enter your password once more. Provide your password and click "**Close account.**"

A confirmation message will appear noting that your account is scheduled for deletion and you have 30 days to change your mind.

And that's it — you have successfully initiated the permanent removal process. After 30 days, your LinkedIn profile will be completely gone.

A LINKEDIN PROFILE USING MOBILE APP

For those who prefer mobile devices, the process is equally straightforward but slightly different due to app navigation. Here's how to remove a LinkedIn profile from the iOS or Android app.

Step 1: Open the LinkedIn App and Go to Your

Profile

Tap your profile picture icon on the top left of the home screen. Then tap **"View Profile."** On your profile page, tap the three-dot menu (**More**) next to the "Add section" or "Open to" button.

Step 2: Access Settings

From the dropdown menu, select **"Settings."** This will take you to a mobile-optimized settings page.

Step 3:

Find Account Preferences

Scroll down and tap **"Account preferences."** Under "Account management," tap **"Close account."** LinkedIn will explain the implications again.

Step 4: Confirm Closure

Tap **"Close account,"** then enter your password when prompted. Confirm once more, and the 30-day deletion process

begins. You'll receive an email confirming the request.

Remember: Deletion from the mobile app works exactly the same way as on desktop. The 30-day retention period applies regardless of the platform used.

WHAT HAPPENS AFTER YOU REMOVE YOUR

PROFILE?

6. **Messages:** You lose access to your inbox. Conversations are deleted from your side, but recipients may still retain copies.
