- A. “You must take it now to catch up.”
- B. “I will skip this dose and notify the nurse.”
- C. “Let me check your chart, and I will also let the nurse know about the nausea.”
- D. “Crush the pill and mix it with applesauce so it goes down easier.”

**Correct answer:** C. Crushing a medication without checking if it is safe to crush is dangerous. You need to verify the order and report the missed dose and the side effect to the supervising nurse. Never administer a medication if there is a question about a missed or refused dose.

### COMMON MISTAKES TO AVOID WHEN PREPARING
