Common electrophilic reagents include protons ( $\text{H}^+$ ), alkyl halides (in  $\text{S}_\text{N}2$  reactions where the carbon bears a partial positive charge), acyl chlorides, and aldehydes. In electrophilic aromatic substitution, a powerful electrophile such as the nitronium ion ( $\text{NO}_2^+$ ) attacks the electron-rich aromatic ring. Understanding the nature of electrophiles is crucial for predicting the outcome of addition and substitution reactions, particularly in the chemistry of alkenes and aromatic compounds. The selectivity of an electrophilic reagent often determines the regiochemistry of the product, a key consideration in the synthesis of complex molecules.

## Radical Reagents

Radicals are species that contain an unpaired electron. They are highly reactive and often participate in chain reactions. Radical reagents can be generated from halogens (such as bromine under light), peroxides, or azo compounds like AIBN. Radical reactions are commonly used for halogenation of alkanes, polymerization, and certain types of addition to alkenes. While radical chemistry can be more difficult to control than polar reactions, it offers unique pathways that are not accessible

through nucleophilic or electrophilic mechanisms. Modern synthetic chemistry has seen a resurgence in radical methods, particularly in photoredox catalysis, where the generation of radical intermediates under mild conditions has opened new avenues for bond formation.

Palladium-catalyzed cross-coupling reactions, such as the Suzuki, Negishi, and Heck reactions, rely on organometallic reagents (e.g., boronic acids, organozinc compounds) and halogenated substrates. Protecting group reagents, such as tert-butyldimethylsilyl chloride (TBDMS-Cl) for alcohols or benzyl chloroformate (Cbz-Cl) for amines, are another essential class; they temporarily mask reactive functional groups to prevent unwanted side reactions during multi-step syntheses. The ability to selectively install and remove protecting groups is a hallmark of sophisticated synthetic planning.

# Grignard Reagents in Carbon-Carbon Bond Formation

# Lithium Aluminum Hydride in Reduction

Lithium aluminum hydride ( $\text{LiAlH}_4$ ) is the reagent of choice for the complete reduction of carbonyl compounds to alcohols. Its action on esters produces primary alcohols, while reduction of amides yields amines. The reagent is extremely reactive with water and protic solvents, necessitating the use of ethereal solvents such as

diethyl ether or THF. The mechanism involves the transfer of a hydride ion ( $\text{H}^-$ ) from aluminum to the electrophilic carbon, followed by hydrolysis to liberate the alcohol. Due to its power,  $\text{LiAlH}_4$  is often used in the final stages of a synthesis when robust functional groups remain, but it can also be used strategically earlier if protecting groups are employed.

# N-Bromosuccinimide in Allylic Bromination

N-Bromosuccinimide (NBS) is a versatile reagent for the selective bromination of organic molecules. In the presence of light or a radical initiator, NBS provides a low, steady concentration of bromine, enabling the substitution of allylic or benzylic hydrogen atoms with bromine. This reaction proceeds via a radical chain mechanism and is a classic method for introducing a functional group at a position adjacent to a double bond. The resulting allylic bromide can then be used in subsequent nucleophilic substitution reactions, making NBS an indispensable tool for the synthesis of terpenes, steroids, and other natural products.
