PRINCIPLE 2: THE COST OF SOMETHING IS WHAT YOU GIVE UP TO GET IT

This principle builds on trade-offs by introducing **opportunity cost**. The true cost of any decision is the value of the next best alternative you forgo. If you choose to attend college, the cost includes not only tuition and books but also the income you could have earned by working full-time. Mankiw emphasizes that opportunity cost is often overlooked, leading to suboptimal

choices. In microeconomics, calculating opportunity costs is essential for both consumers and firms when allocating scarce resources.

PRINCIPLE 3: RATIONAL PEOPLE THINK AT THE MARGIN

Rational decision-makers compare the additional benefits and costs of a small change in their actions. This is **marginal analysis**. For instance, an airline might sell a seat at a very low price just before departure if the marginal benefit (revenue from that seat) exceeds the marginal cost (the negligible cost of carrying one more passenger). Mankiw explains that many of life’s most important decisions involve marginal trade-offs rather than all-or-nothing choices. This principle underpins supply

and demand dynamics, pricing strategies, and consumer behavior.

PRINCIPLE 4: PEOPLE RESPOND TO INCENTIVES

Incentives are rewards or punishments that influence behavior. When the price of a good rises, consumers tend to buy less, and producers tend to supply more. This principle is the engine of market economies. Mankiw uses vivid examples, such as seatbelt laws and their effect on driving behavior, to illustrate that people adjust their actions based on the incentives they face. Understanding incentives is crucial for designing effective policies and predicting market outcomes. PRINCIPLE 5: TRADE CAN MAKE EVERYONE BETTER OFF

This principle counters the zero-sum fallacy. When two parties voluntarily trade, both can benefit because each values what they receive more than what they give up. Trade allows for specialization, which increases efficiency and output. Mankiw points out that trade between individuals, firms, or nations is not like a sports competition where one wins and the other loses. Instead, it is a positive-sum game. This idea is foundational for understanding

comparative advantage, which explains why countries export certain goods and import others.

PRINCIPLE 6: MARKETS ARE USUALLY A GOOD WAY TO ORGANIZE ECONOMIC ACTIVITY

Mankiw famously writes about the **invisible hand**, a metaphor coined by Adam Smith. In a market economy, the decentralized decisions of millions of buyers and sellers, each acting in their own self-interest, often lead to outcomes that benefit society as a whole. Prices serve as signals that guide resources to their most valued uses. While markets are not perfect, Mankiw argues that they are remarkably effective at coordinating economic activity. cornerstone of microeconomics and supports the case for free markets in the absence of market failures.

PRINCIPLE 7: GOVERNMENTS CAN SOMETIMES IMPROVE MARKET OUTCOMES

Despite the power of markets, there are situations where they fail to produce efficient or equitable results. **Market failures** include externalities (like pollution), market power (like monopolies), and public goods. In such cases, government intervention can potentially improve outcomes. SUPPLY, DEMAND, AND MARKET EQUILIBRIUM

The **law of demand** states that, all else equal, the quantity demanded of a good falls as its price rises. Conversely, the **law of supply** holds that the quantity supplied rises as price rises. The intersection of supply and demand curves determines the equilibrium price and quantity in a competitive market. Mankiw uses real-world examples, such as the market for ice cream or gasoline, to illustrate how

shifts in supply or demand—due to changes in tastes, income, technology, or input costs—lead to new equilibria.

Elasticity is another key concept in Mankiw's microeconomics. **Price elasticity of demand** measures how responsive quantity demanded is to a price change. Goods with close substitutes (like soda) tend to have elastic demand, while necessities (like insulin) have inelastic demand. Understanding elasticity helps businesses set prices and governments predict the impact of taxes. Mankiw's clear explanations and intuitive examples make these technical concepts feel approachable.

THE ROLE OF GOVERNMENT IN

MICROECONOMICS
