UNDERSTANDING THE MOORISH NATIONAL TAX EXEMPT CARD: HISTORY, CLAIMS, AND LEGAL REALITY

They claim that as descendants of the "Moorish Empire," they are not "Fourteenth Amendment citizens" of the United States and therefore not subject to its tax jurisdiction. The card is their

primary tool for asserting this position in interactions with employers, banks, and government agencies.

Historical Background and the Roots of the Movement

To understand the Moorish National Tax Exempt Card, one must first understand the Moorish sovereign movement from which it springs. This movement traces its origins to the early 20th century and the teachings of Noble Drew Ali, who founded the Moorish Science Temple of

To the uninitiated, this language can be confusing. However, it is firmly rooted in a set of legal fictions that have been uniformly rejected by courts across the United States.

Legal Analysis: Why the Moorish National Tax

Exempt Card Does Not Work

From a legal standpoint, the Moorish National Tax Exempt Card has **no validity whatsoever**. Every federal court that has examined claims based on the Moorish sovereign defense, including claims of tax exemption, has dismissed them as frivolous. The Internal Revenue Service (IRS) does not recognize the card, and employers who accept it as a valid basis for non-withholding of taxes are exposing themselves to significant penalties.

The central legal flaw in the card's premise is its misinterpretation of the U.S. tax code. The Internal Revenue

Code imposes a federal income tax on the taxable income of every individual who is a "person" within the meaning of the law, regardless of race, ethnicity, or claimed nationality. The 16th Amendment, which authorizes Congress to tax income, contains no exemption for Moorish Americans or any other group based on historical treaties. The Treaty of Peace and Friendship with Morocco is a treaty of commerce and navigation, not a tax treaty. It grants certain rights related to trade and protection but does not exempt anyone from U.S. federal income taxes.

Moreover, the argument that Moorish Americans are not "Fourteenth Amendment citizens" is a common sovereign citizen trope that courts have repeatedly debunked. The Fourteenth

Amendment defines citizenship broadly: "All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside." This language leaves no room for a separate "Moorish" nationality that exists outside U.S. jurisdiction.

Official IRS and Court Stances

The IRS has explicitly identified the Moorish sovereign movement and its tax exemption claims as a **frivolous tax argument**. The agency maintains a list of "Frivolous Positions" in its Internal Revenue Manual, and claims based on Moorish nationality fall squarely within

that category. Filing a tax return that claims exemption based on the Moorish National Tax Exempt Card can trigger significant fines. Under current law, the penalty for filing a frivolous return is **\$5,000**, and repeat offenders face even higher penalties.

Federal courts have been equally clear. In case after case, judges have dismissed Moorish sovereign arguments with language that underscores their lack of merit. For example, in *United States v. Washington*, a federal appellate court noted that "the Moorish sovereign defense has been rejected time and time again by every court to consider it." In another case, *United States v. Davis*, the court stated bluntly: "The defendant's claim of Moorish nationality does not exempt him from federal tax liability."

Attempting to use the card to dismiss criminal charges for tax evasion, failure to file, or filing false returns has uniformly resulted in conviction, often with enhanced sentences for obstruction of justice.

The Risks of Using the Card

Beyond its legal invalidity, the **Moorish National Tax Exempt Card** carries serious practical risks for those who rely on it. These risks extend far beyond a simple denial of the claimed exemption. Individuals who withhold taxes based on the card may face:

- **Back taxes, interest, and**

- **Civil judgments and liens:** The IRS can file tax liens and levy wages or property to collect unpaid taxes, creating long-term financial difficulties.

Perhaps most troubling is the advice some card promoters give to their followers: to refuse to cooperate with the judicial system, to file anomalous court documents, or to assert "sovereign immunity" when confronted by law

enforcement. This advice has led many individuals into deeper legal trouble, including incarceration for contempt of court or for filing frivolous motions.

Distinguishing Legitimate Tax Exemptions from False Claims
