The markdown percentage is always based on the original price. A 25% markdown on a \$100 item reduces the price to \$75. However, you must ensure that the new price still covers your variable costs and contributes to fixed overhead. Overly aggressive markdowns can damage brand value and profitability. Calculating Trade Discounts and Net Prices

In business-to-business transactions, discounts are often offered in chains, such as “20/10/5.” This means a 20% discount, then 10% off the reduced price, then 5% off that result. Compound interest, however, grows exponentially because interest is earned on previously accumulated interest. The formula for future value is $FV = PV \times (1 + r/n)^{(n \times t)}$, where PV is present value, r is annual rate, n is number of compounding periods per year, and t is years. For example, \$1,000 invested at 5% compounded annually for 3 years grows to \$1,157.63. If compounded monthly, it becomes \$1,161.80. The difference seems small, but over longer periods, compounding creates substantial wealth. Discounting: Present Value and Investment Decisions

INVENTORY MANAGEMENT MATH: BALANCING COSTS AND AVAILABILITY

Two important calculations are the Economic Order Quantity (EOQ) and reorder point. EOQ determines the order quantity that minimizes total inventory costs (ordering + holding).
