The VSL, often the Masonic Holy Bible, is the ultimate source of that divine will which man seeks to understand.

The Bible is the rule and guide for a Mason's faith and practice. It is from this book that a Mason learns his duties to God, his neighbor, and himself. During the opening and closing of a lodge, the Bible is a central focus. It is also used during the

administration of obligations, where candidates place their hands upon it as a sign of the solemnity and sacred nature of the promises they are making. This act underscores the Masonic principle that all obligations are taken in the presence of a Supreme Being.

The Bible in the Three Degrees of Freemasonry

The **Masonic Holy Bible** plays a specific and evolving role in each of the three foundational degrees of Freemasonry.

- **The Entered Apprentice Degree:** In this first degree, the candidate is introduced to the Bible as the "Great Light" and is taught that it is the rule and guide for his faith and practice. The Bible is used to administer the obligation of

this degree. The candidate's attention is drawn to the Bible, the Square, and the Compasses, and he is taught that these three great lights rule and govern the lodge.

- **The Fellow Craft Degree:** As the Mason progresses to the second degree, he is encouraged to study the liberal arts and sciences, which are symbolically represented in the construction of King Solomon's Temple. The Bible becomes a source of wisdom and knowledge, particularly the books of Proverbs and Ecclesiastes. The Mason is taught to seek "more light in Masonry" by understanding the symbolic meanings contained within the scripture.
- **The Master Mason Degree:** This is the highest of the three symbolic degrees, and it deals with the profound themes of life, death, and immortality. The Bible is central to this degree, offering comfort and hope. The opening of the Bible to a specific passage, often Ecclesiastes 12:1-7 or 1 Thessalonians 4:13-18, underscores the Masonic belief in the resurrection and the immortality of the soul. The lessons of this degree are the most solemn, and the Bible provides the ultimate source of solace and assurance.

SYMBOLISM AND THE MASONIC HOLY BIBLE

The Open Bible: A Symbol

of Revelation

One of the most powerful and consistent symbols in a Masonic lodge is the open Bible. It is never closed during lodge hours. This signifies that the will of God is always available to guide the deliberations of the lodge. It represents the concept of divine revelation—that the principles of truth and morality are not hidden but are open for all to see and follow. The act of opening the Bible is symbolic of dispelling darkness and bringing light into the lodge room.

The specific page to which the Bible is opened is also symbolic. While many lodges open to the first chapter of John ("In the beginning was the Word, and the Word was with God, and the Word was God"), others may use Psalm 133 ("Behold, how good and how pleasant it is for brethren to dwell together in unity"). The choice of passage reflects the theme of the meeting or the degree being worked, but the constant presence of the open Bible reminds all Masons of their continuous duty to God and humanity.

The Square and Compasses on the Bible

In a Masonic lodge, the Square and Compasses are placed directly on the open Bible. This is not a casual placement but a deeply symbolic act. The Square, a symbol of morality and virtue,

lies upon the divine word, signifying that our actions must be squared with the moral law of God. The Compasses, a symbol of spiritual boundaries and self-discipline, rest upon the Bible to remind the Mason that his passions and desires must be circumscribed by the divine will.

The juxtaposition of these three items—the Bible, the Square, and the Compasses—represents the complete system of Masonic ethics. The Bible provides the divine law, the Square provides the rule of action, and the Compasses provide the principle of restraint. Together, they form the foundation of a Mason's character. The placement of the Square and Compasses on the Masonic Holy Bible is a common visual for the craft and is featured prominently on the cover of many Masonic Bibles and regalia.

HOW TO CHOOSE A MASONIC HOLY BIBLE

If you are a Freemason, or if you are looking for a meaningful gift for a Mason, choosing the right Bible is a personal and important decision. Here are a few considerations to guide you:

1. **Translation:** Determine which translation you prefer. A Bible that lies flat when open is also a practical feature for lodge use, particularly during readings.
4. **Presentation Quality:** If you are purchasing a Bible for a presentation, consider a "gift edition" with a presentation page, a commemorative box, and perhaps a ribbon marker. The aesthetic quality, including the cover art and the clarity of the print, will all contribute to the dignity of the gift.
5. **Size and Portability:** Some Masonic Bibles are large, folio editions designed to be placed on the lodge altar. These are impressive and symbolic but not meant for personal study. A personal "lodge Bible" should be a comfortable size to carry in a briefcase or to keep on a personal desk.
