## BUSINESS LETTER

Before you begin typing or writing, it is crucial to understand the standard structure. Each component of a business letter has a specific place and purpose. A typical formal letter consists of several key sections, each separated by a line break for clarity.

### 1. Your Contact Information (The Header)

This includes your full name, your job title (if applicable), your company name, your full address, your phone number, and your professional email address. ## 2. The Date

## 3. Recipient's Contact Information (The Inside Address)

This includes the recipient's full name and title, the company name, and the company's full address. Using the correct spelling and title (e.g., "Mr.," "Ms.," "Dr.," or "Professor") is critical and demonstrates your attention to detail. If you are unsure of the recipient's gender or preferred title, it is acceptable to use their full name (e.g., "Jordan Smith").

## 4. The Salutation

The salutation is your greeting. The standard and safest option is "Dear [Title] [Last Name]: " (e.g., "Dear Dr. Johnson: "). If you have a close professional relationship with the recipient, you might use their first name. If you do not know the recipient's name, use a general salutation like "Dear Hiring Manager:" or "Dear Customer

Service Team:". Always follow the salutation with a colon, not a comma, in business letter format.

## 5. The Body of the Letter

This is the core of your message. The body should be single-spaced with a double space between paragraphs. It should be clear, concise, and well-organized. The first paragraph typically introduces the purpose of the letter. The middle paragraphs provide supporting details, evidence, or explanations. The final paragraph should clearly state your desired outcome or call to action.

## 6. The Complimentary Close

This is your sign-off phrase. Common closings include "Sincerely," "Respectfully," "Best regards," "Cordially," or "Yours truly." "Sincerely" is the most widely accepted and safest choice for formal business correspondence. Capitalize only the first word of the closing phrase and follow it with a comma.

## 7. The Signature Block

Leave about four blank lines for your handwritten signature. Below this space, type your full name. If applicable, include your job title on the line below your typed name. This creates a clear

### CHOOSING THE RIGHT BUSINESS LETTER FORMAT

---

There are three primary formats used in professional correspondence. Your choice will depend on your company's standards and the level of formality you wish to project. Understanding these formats is a key part of mastering **how to write a proper business letter**.

- **Block Format:** This is the most common and widely accepted format. All elements of the letter—from your header to the signature block—are aligned to the left margin. There are no indents. Paragraphs are separated by a double space. This format is clean, modern, and easy to read.
  - **Modified Block Format:** In this format, your contact information, the date, the complimentary close, and the signature block are aligned to the center of the page or slightly to the right. The rest of the letter, including the inside address, salutation, and body, remains left-aligned. This format is slightly more traditional and visually balanced.
  - **Semi-Block Format:** This format is similar to modified block, but with one key difference: the first line of each paragraph in the body is indented. This is the most traditional and formal style, though it is less common today.

Now that you understand the components and formats, let us walk through the process of actually writing the letter. Follow these steps to ensure your communication is effective and professional.

## Step 1: Define Your Purpose and Audience

Before you write a single word, ask yourself: What is the goal of this letter? Do I want to convince, inform, request, or complain? Who is my reader? What do they care about? A letter requesting funding for a project will have a very different tone and structure than a letter of thanks. Understanding your purpose and audience is the most critical step in **how to write a proper business letter**.

## Step 2: Choose the Correct Format

Select the format that best suits the context. For most modern business situations, the Block Format is your best choice. It is straightforward, professional, and reduces the risk of formatting errors. Use a standard, readable font like Times New Roman,

Arial, or Calibri in 10 to 12-point size.

## Step 3: Write the Header and Address

Start with your contact information at the top of the page. Follow this with the date, and then the recipient's contact information. Double-check the spelling of the recipient's name and the accuracy of their address. A small error here can make a poor first impression.

## Step 4: Craft a Strong Salutation

Use a formal salutation. "Dear Mr. [Last Name]:" or "Dear Ms. [Last Name]:" are always safe options. Avoid "To Whom It May Concern" if at all possible; it is impersonal and suggests you did not do your research. Instead, make a phone call or check the company website to find the correct contact person.

## Step 5: Write a Clear and

## Purposeful Body

This is where the quality of your writing truly matters. Follow the "three-paragraph rule" for clarity.

1. **Opening Paragraph:** State your purpose immediately. Be direct and professional. For example: "I am writing to apply for the Senior Analyst position advertised on LinkedIn." or "I am writing to formally request a refund for the defective product I purchased on October 15, 2023."
2. **Middle Paragraphs:** Provide the necessary context, evidence, or details. Use facts, figures, and specific examples to support your claims. Keep paragraphs focused on a single idea. If you have multiple points to make, use bullet points within the body for clarity, but keep the language formal. For example: "The product has failed to perform as advertised due to the following issues: (1) It stopped charging after three days. (2) The accompanying software is incompatible with my operating system."
3. **Closing Paragraph:** Clearly state your desired outcome or call to action. This is not the place for vague statements. Be specific. For example: "I kindly request a full refund for the purchase price of \$249.99. I look forward to your response by November 1, 2023." or "Thank you for your time and consideration. I look forward to discussing my qualifications further in an interview."

## Step 6: Choose a Professional Complimentary Close

As mentioned, "Sincerely," is almost always the correct choice. It is formal, respectful, and universally accepted. Other options like "Best regards," are slightly less formal but still professional. Leave four blank lines for your signature after the close.

## Step 7: Proofread and Revise with Extreme Care

This step is non-negotiable. A business letter with a typo or grammatical error can severely damage your credibility. Read the letter out loud to catch awkward phrasing. Use a spell-checker, but do not rely on it completely. It is often helpful to ask a trusted colleague to review the letter before you send it. Pay special attention to the recipient's name, the date, and your contact information.

### **COMMON TYPES OF BUSINESS LETTERS**

While the basic structure remains the same, the content and tone of a business letter will vary depending on its purpose. Here are a few common scenarios and how to handle them.

## Cover Letters

A cover letter is your personal marketing document. It should not simply repeat your resume. Instead, use it to tell a story about your skills and experience, connecting them directly to the needs of the employer. Your opening paragraph should state the job you are applying for and express your enthusiasm. The body should highlight 2-3 key accomplishments that are relevant to the role. The closing should request an interview and thank the reader for their consideration.

## Complaint or Adjustment Letters

When writing a complaint letter, remain polite and professional, even if you are frustrated. State the problem clearly and factually in the first paragraph. Describe what you have already done to resolve the issue. Attach copies (not originals) of receipts, warranties, or other supporting documents. Clearly state the resolution you expect, such as a refund, replacement, or service credit. A respectful tone is far more likely to get a positive result than an angry one.

## Inquiry Letters

An inquiry letter asks for information or a favor. Be respectful of the recipient's time. State your request clearly and concisely. Explain why you are asking and how the information will be used. Make it as easy as possible for the recipient to respond. Include a self-addressed, stamped envelope if you are sending a physical letter. Express gratitude for their help.

## Thank-You Letters

A thank-you letter is a powerful tool for building professional relationships. It should be sent promptly after an interview, a

meeting, or a favor. Be specific about what you are thanking the person for. Mention a particular detail from the conversation to show you were listening. Reiterate your appreciation and express interest in maintaining the relationship.
