This four-factor test examines: (1) the length of the delay; (2) the reason for the delay (e.g., deliberate prosecution tactic vs. court congestion); (3) whether the defendant asserted the right; and (4) whether the defendant suffered prejudice (e.g., pretrial incarceration, anxiety, or impaired defense). No single factor is dispositive; courts must weigh them all together. A delay of several years, however, will almost always trigger scrutiny, and if the government is found to have acted in bad faith, the remedy—dismissal of the charges with prejudice—is severe but necessary to deter future misconduct. This framework ensures that the right remains a living, breathing guarantee rather than a hollow promise.

Transparency as a Check on Power
