He picked up his ukulele and began to sing. The recording you hear today is that single, unedited take. There were no overdubs, no auto-tune, no second chances. It was pure, raw, and perfect.

The recording sat on a shelf for years before being released on his 1993 album "Facing Future." It was not initially a hit, but over time, it found its way into films, television shows, commercials, and funerals. It became a soundtrack for moments of profound emotion. The fact that it was recorded in one take adds a layer of vulnerability to the meaning of the lyrics. This was not a polished, manufactured pop song. It was a man sitting alone in a studio, singing his heart out to a song that reminded him of hope.

ANALYZING THE LYRICS: A DEEPER MEANING OF "SOMEWHERE OVER THE RAINBOW"

"Someday I'll wish upon a star / And wake up where the clouds are far behind me / Where troubles melt like lemon drops / Away above the chimney tops / That's where you'll find me."

The imagery of "troubles melting like lemon drops" is deceptively simple. Lemon drops are small, sweet, and fleeting. The comparison suggests that troubles are temporary, that sweetness can dissolve bitterness. For Iz, who struggled with his health and the political struggles of his people, this was not naive optimism. It was a radical act of hope. He chose to sing about melting troubles, not because they did not exist, but because he believed they could be transformed.

The song transitions into "What a Wonderful World," originally made famous by Louis Armstrong. Iz sings:

"I see trees of green, red roses too / I see them bloom for me and you / And I think to myself, what a wonderful world."

This transition is key to understanding the full meaning. In Iz's medley, the rainbow is not an escape to a distant fantasy. It is a bridge to appreciating the beauty of the world as it is. He is saying: yes, I dream of a better place, but I also see the roses blooming right now. There is a bittersweet tension

between longing for what is not here and celebrating what is.

THE UKULELE: AN INSTRUMENT OF INNOCENCE AND GRIEF

You cannot discuss the meaning of this song without acknowledging the instrument. Iz chose to accompany himself on the ukulele, an instrument often associated with lightheartedness, tropical vacations, and innocence. But in Iz's hands, the ukulele becomes an instrument of profound melancholy. The high, bright notes contrast with the depth of his voice. This tension creates a feeling of "happy sadness"—a term psychologists sometimes use to describe the emotion of bittersweet nostalgia. The ukulele's cheerful timbre makes the sadness bearable, and the sadness makes the cheerfulness meaningful.

This instrument choice also reflects Iz's Hawaiian identity. The ukulele is deeply rooted in Hawaiian culture. By using it to perform a classic American song, Iz was making a statement. He was saying that Hawaiian culture can hold universal emotions. He was claiming a place for his people in the global musical conversation. The meaning of the lyrics, then, is also about cultural sovereignty and the power of softness.

WHY THIS VERSION RESONATES AT FUNERALS AND CELEBRATIONS

It is striking how often this song is played at funerals, memorials, and moments of collective grief. It was used in tributes after 9/11, during the COVID-19 pandemic, and for countless private ceremonies. Why? Because the lyrics of "Somewhere Over The Rainbow" as sung by Iz offer a vision of death not as an end, but as a return. "Where troubles melt like lemon drops" suggests a release from suffering. "That's where you'll find me" suggests continuity beyond physical presence.

For many, the song has become a way to say goodbye without bitterness. It allows mourners to feel the full weight of their loss while also feeling a glimmer of hope. Iz himself died young, at age 38, in 1997. His death was mourned by the entire state of Hawaii. His body lay in state at the State Capitol, and thousands of people came to pay respects. His ashes were scattered into the Pacific Ocean. When you listen to the song now, you hear the voice of a man who knew he would not live long. There is an urgency to his gentleness. He was singing for himself as much as for anyone else.

It has been covered by artists around the world, but no one has matched the emotional depth of the original. The reason is simple: you cannot replicate authenticity. Iz was not performing. He was being.

In 2020, the Library of Congress added the recording to the National Recording Registry, recognizing it as "culturally, historically, or aesthetically significant." This is a formal acknowledgment of what millions already knew: this song is a treasure. The meaning of the lyrics continues to evolve. For a child, it is a lullaby. For an activist, it is a rallying cry. For a mourner, it is a comfort. For a dreamer, it is a permission slip to keep dreaming.

WHY WE KEEP COMING BACK TO THIS SONG

In an age of digital perfection, where every note can be corrected and every vocal can be tuned, the raw humanity of Iz's recording stands out. You can hear him breathe.
