UNDERSTANDING THE BASICS OF ORAL FLUID DRUG TESTING

1. **Brush your teeth thoroughly** for at least two minutes, paying special attention to the gum line and tongue.
2. **Floss carefully** to remove any trapped particles between teeth.
3. **Scrape your tongue** using a tongue scraper to remove bacteria and debris where drug residues may accumulate.
4. **Use a high-quality mouthwash** containing hydrogen peroxide or alcohol to further cleanse the oral cavity.
5. **Rinse with water** several times in the hours leading up to the test.

Mouthwashes and Rinses

WHAT TO DO ON THE DAY OF THE TEST

1. Mix equal parts 3% hydrogen peroxide and water.
2. Swish the solution in your mouth for 30 to 45 seconds without swallowing.
3. Spit it out and rinse thoroughly with plain water.
4. Repeat the process once more if desired.

While anecdotal evidence supports this approach, scientific data is limited. Use caution as undiluted hydrogen peroxide can irritate oral tissues. This method is best used shortly before the test, within 30 minutes, to maximize potential benefits.

Apple Cider Vinegar Rinse

Another common home remedy involves apple cider vinegar. Proponents believe the acidic nature of vinegar can help break down drug compounds in the mouth. To try this method:

1. Dilute one tablespoon of raw apple cider vinegar in a cup of water.
2. Swish the mixture for 20 to 30 seconds.

As with hydrogen peroxide, the effectiveness of apple cider vinegar is largely supported by anecdotal reports rather than rigorous scientific research. It is generally safe for oral use when diluted properly.

TEST

The hours immediately before your saliva drug test are critical. Here is a step-by-step plan for the day of testing:

1. **Wake up early** to allow yourself plenty of time to prepare without rushing.
