Beyond the core -at words, the story includes a carefully limited set of high-frequency sight words such as *the, a, and, see, go, look*. This combination of decodeable words and sight words gives children a complete reading experience. They can apply their phonics knowledge to the -at words while relying on memorization for the sight words, which are often irregular. This balanced approach is essential for building reading fluency. The story might also

introduce a few challenge words that are supported by the illustrations, such as *night* or *fly*, but the overwhelming majority of the text is accessible to a child who is learning the -at word family. The rhythmic, rhyming text further supports decoding by providing a predictable auditory pattern.

HOW TO USE WORD FAMILY TALES AT A BAT NAMED PAT EFFECTIVELY
