For example, a student in the "Software and Systems Development" pathway within the Information and Communication Technologies sector

would have pathway standards that include writing code in multiple programming languages, understanding database management, and applying principles of user interface design. Pathway standards are developed in collaboration with industry experts, ensuring they reflect the actual skills needed for entry-level employment or advanced study.
