# The Executive Summary : Your Elevator Pitch

The executive summary is arguably the most critical section. It appears at the top of your resume and must immediately hook the reader. Unlike a standard objective statement, an executive summary is

a powerful branding statement that encapsulates your career narrative, core competencies, and the distinct value you bring. When learning **how to write an executive resume**, mastering this section is non-negotiable.

A strong executive summary should include:

- **Your professional identity:** Clearly state your title and industry expertise. For example, "Transformational Chief Financial Officer with 20+ years of experience in global financial services."
- **Key differentiators:** Highlight what

makes you unique, such as a track record of turning around underperforming divisions, leading successful IPOs, or driving digital transformation.

- **Quantified impact:** Include one or two impressive metrics that summarise your career achievements, such as "consistently delivered 15% year-over-year revenue growth" or "led cost reduction initiatives saving \$50M annually."
- **Leadership philosophy:** Briefly mention your leadership style, whether it is visionary,

collaborative, or results-driven.

Keep your executive summary concise—three to five sentences is ideal. It should be written in a confident, authoritative tone that leaves no doubt about your capability to lead at the executive level.

## Strategic Core Competencies and Skills

The skills section on an executive resume should go beyond generic technical abilities. Instead, focus on strategic competencies that

align with senior leadership roles. This is an opportunity to integrate key terms naturally while demonstrating your breadth of expertise. When considering **how to write an executive resume** that stands out, curate a list of 10 to 15 core competencies that reflect the language used in your target industry and role.

Examples of executive-level competencies include:

- Strategic Planning and Execution
- Mergers and Acquisitions (M&A) Integration
- Organisational Transformation
- Stakeholder Management
- Revenue Growth

and Profitability Improvement

- Board and Investor Relations
- Talent Development and Succession Planning
- Risk Management and Governance
- Global Operations Management
- Digital Innovation and Technology Strategy

Present these skills in a clean, scannable format, either as a bulleted list or a two-column layout. This allows recruiters to quickly assess your alignment with their requirements.

# Professional Experience: Showcasing Leadership and Results

The experience section is the heart of your executive resume. This is where you prove your claims with concrete evidence. Rather than listing responsibilities, each bullet point should follow a results-

oriented format. A widely accepted approach is the CAR method (Challenge, Action, Result) or the STAR method (Situation, Task, Action, Result). When exploring **how to write an executive resume** that commands attention, prioritise impact over activities.

For each role, include:

- **Company name, location, and dates of employment.**
- **Your title and scope of responsibility,** such as the size of the team you led or the budget you managed.
- **3 to 6 bullet points highlighting major achievements.**

Start each bullet with a strong action verb (e.g., spearheaded, transformed, optimised, led, delivered).

- **Quantified outcomes whenever possible.**

Numbers provide credibility and make your accomplishments tangible. For example, "Improved operational efficiency by 30% across five regional offices, resulting in annual cost savings of \$12M."

Focus on the most recent 15 to 20 years of your career. Older roles can be summarised briefly. If you have held multiple

executive positions, group them under a heading like "Executive Leadership Experience" to emphasise career progression.

## **HOW TO WRITE BULLET POINTS FOR EXECUTIVE IMPACT**

To deepen your understanding of **how to write an executive resume**, consider the difference between a standard bullet point and an executive-level bullet point:

### **Standard:**

"Responsible for managing the sales team and increasing revenue."

### **Executive:**

"Spearheaded a company-wide sales transformation that increased annual revenue from \$150M to \$220M within 18

months, while reducing customer churn by 25%."

The executive version is specific, quantifiable, and demonstrates leadership influence across the organisation. Every bullet point should pass the "so what?" test—if the reader cannot immediately see the significance of the accomplishment, revise it.

## THE EXECUTIVE EDUCATION AND CREDENTIALS SECTION

---

Education holds particular weight at the executive level. An MBA from a respected institution or a relevant advanced degree can be a significant advantage. When thinking about **how to write an executive**

**resume**, place your education section after your experience if you have extensive work history. However, if you have notable academic credentials that are highly relevant to your target role, consider leading with a combined summary and education section. Include the following details:

- Degree and field of study
- University name and location
- Graduation year (optional, but can be included)
- Honours or distinctions (e.g., cum laude, Dean's list)

Additionally, list executive education programmes, certifications, or board memberships. Examples include:

School Advanced Management Program

- Certified Public Accountant (CPA) or Chartered Financial Analyst (CFA)
- Board of Directors certification from a recognised governance institute
- Executive coaching or leadership development programmes

This section reinforces your commitment to continuous learning and professional development, which is critical for senior leaders navigating rapidly changing industries.

## DESIGN FOR EXECUTIVE RESUMES

---

Content is paramount, but presentation matters significantly. An executive resume must look polished, professional, and easy to read. Avoid overcrowded layouts, excessive colours, or creative fonts. The design should reflect your personal brand and the norms of your industry. For instance, a creative executive might have slightly more design flexibility than a financial services executive. However, the golden rule when learning **how to write an executive resume** is to prioritise clarity and professionalism.

Key formatting tips include:

- **Use a clean, two-column or single-column layout.** Two columns can be effective for skills and contact information, but ensure the main content column remains the focus.
  - **Choose a professional font.** Arial, Calibri, Helvetica, or Garamond are safe choices. Keep font size between 10 and 12 points for body text, with larger sizes for headings.
  - **Incorporate white space generously.** Margins of at least 0.75 inches and clear spacing between sections enhance readability.
  - **Limit the resume to two pages.** While standard resumes often fit on one page, executives typically require two pages to adequately showcase their career arc. However, be ruthless about including only the most impactful information.
  - **Use bullet points consistently.** Avoid paragraphs of text. Bullet points are easier to scan and allow recruiters to quickly absorb your achievements.

## EXECUTIVE RESUME FOR

### SPECIFIC ROLES

A common mistake among senior leaders is using a generic resume for all applications.

Executives must tailor their resumes for each opportunity to demonstrate genuine interest and fit.

Understanding **how to write an executive resume** includes mastering the art of customisation.

Research the target company

thoroughly—review its mission, financial performance, recent news, strategic priorities, and leadership team. Then, align your resume content accordingly.

For example, if a company is undergoing

digital transformation, emphasise your experience leading technology initiatives and change management. If the organisation is focused on expanding globally, highlight your international experience and cross-cultural leadership. This level of customisation shows that you have done your homework and are genuinely invested in solving the organisation's specific challenges.

### LEVERAGING KEYWORDS FOR EXECUTIVE SEARCHES

While executive roles are often filled through networks and executive search firms, many large

organisations still use applicant tracking systems (ATS) to filter candidates. Therefore, incorporate industry-relevant keywords naturally throughout your resume. These keywords may include terms like "P&L management," "strategic planning," "board relations," "EBITDA improvement," "organisational design," and "cultural transformation." However, avoid keyword stuffing—your resume must still read naturally for human decision-makers.

### **COMMON PITFALLS TO AVOID WHEN WRITING AN EXECUTIVE RESUME**

Even highly accomplished leaders can undermine their

candidacy with avoidable mistakes. As you consider **how to write an executive resume**, be mindful of these common pitfalls:

- **Being too vague:** General statements like "improved revenue" or "managed a team" do not convey the scale of your impact. Always quantify when possible.

- **Using passive language:** Phrases like "was involved in" or "responsible for" weaken your impact. Use active, powerful verbs instead.
- **Including personal information:** Age, marital

status, religion, or unrelated hobbies have no place on an executive resume.

Avoiding these errors will ensure your resume presents you as a polished, strategic, and self-aware leader.
