ANNE FRANK: UNCOVERING THE CITY THAT SHAPED HER EARLY YEARS

Edith followed with the children later in 1933. The family initially settled in an apartment on the Merwedeplein square in the Rivierenbuurt district of Amsterdam. Anne was just four years old. She was uprooted from the only home she had ever known, leaving behind her grandmother, cousins, and friends in Frankfurt. This migration is the pivotal moment that transforms Anne from a German girl into the famous Dutch diarist we know today.

FRANKFURT’S LEGACY IN ANNE’S WRITING

A Distant Memory of Birthplace

Anne’s diary does not dwell heavily on her life in Frankfurt, primarily because she was so young when she left. However, the influence of her birthplace is present throughout her writing. She wrote in German in her earliest notebooks, and her family maintained German traditions at home. The structure of her language, her cultural references, and her sense of order were all shaped by her first years in Germany.
