INTERNATIONAL PACKAGE TRACKING: A SPECIAL CASE

Tracking a package that crosses international borders adds another layer of complexity. When sending or receiving items from another country, you are often dealing with multiple carriers and customs agencies. Learning how to track a package internationally requires a bit more diligence.

The Role of

Customs and Handoffs

When a package travels internationally, it is often handed off from the originating carrier to a local carrier in the destination country.
