There are several ways to create an electronic signature, ranging from highly informal to enterprise-grade. Choose the method that best matches your needs for security, professionalism, and ease.

# 1. Using Built-in Tools on Your Computer

Most operating systems and common office software include basic e-signature features at no extra cost.

- **Microsoft Word**

- Insert a signature line, then type your name or use the drawing tool to create a signature. Word also allows you to add a digital signature line if you have a certificate.
- **Adobe Acrobat Reader** – Open a PDF, click the “Fill & Sign” tool, and you can type, draw, or upload an image of your signature. It’s free for basic usage.
- **Preview on Mac** – Use the markup toolbar to add your signature by drawing with a trackpad or using the built-in camera to capture a written signature on paper.
- **Google Docs** – Insert a drawing, write your signature using the mouse or touchpad, and save it as an image. Insert that image into the document.

These methods are perfect for ad-hoc signing when you don’t need a formal audit trail.

For frequent signing or business workflows, dedicated platforms offer the best combination of security, ease of use, and compliance. Some of the most popular include:

- **DocuSign** – Industry leader with robust features including templates, workflow automation, and integration with hundreds of apps. Free tier available for sending up to 5 documents per month.
- **Adobe Sign** – Seamlessly integrates with Adobe Acrobat and the

Document Cloud. Excellent for large enterprises with high-volume signing needs.

- **HelloSign** (Dropbox) – Simple interface ideal for small businesses. Offers free basic plans with up to 3 signatures per month.
- **PandaDoc** – Great for sales teams with proposal creation and e-signature in one platform.

These platforms provide legal evidence, encryption, and often support advanced digital signatures with certificates.

# Free Signature Generators

If you only need a one-time signature image, free websites like *esignature.io*, *signnow.com*, or *smallpdf.com* allow you to create and download a signature image. You can typically draw with your mouse, type, or upload a photo of your handwritten signature.

**Caution:** Free generators may store your signature data on their servers, so avoid using them for sensitive documents. Also, these images lack tamper-proofing and are easy to copy, so they are not

recommended for legal contracts.

## 4. Mobile Apps for iOS and Android

Mobile apps let you sign documents on the go using your smartphone or tablet. Many of the desktop software mentioned offer mobile versions:

- **DocuSign mobile app** – Full functionality including camera capture of signatures.
- **Adobe Fill & Sign** – Free app perfect for filling and signing PDFs.
- **Apple's Markup**

**in Mail or Photos** – Built-in feature that lets you create a signature using your finger or Apple Pencil.

Mobile signing is especially useful when you receive documents via email and need to sign immediately.

### **STEP-BY-STEP: HOW TO MAKE AN ELECTRONIC SIGNATURE USING COMMON TOOLS**

Below are detailed instructions for creating an electronic signature using three popular methods. These cover the most common scenarios you'll encounter.

## Method

# A: Using Adobe Acrobat Reader (Free)

1. Open the PDF document you need to sign in Adobe Acrobat Reader.
2. Click on the **"Fill & Sign"** tool in the right panel.
3. In the Fill & Sign toolbar, click the **"Sign"** button (it looks like a pen nib).
4. A dropdown menu will appear: choose **"Add Signature"**.
5. You can now create your

signature in one of three ways:

- **Type** – Type your name in the box; Acrobat will convert it to a cursive-style font resembling a signature.
- **Draw** – Draw your signature with your mouse, touchpad, or touchscreen.
- **Image** – Upload a scanned image or a photo of your handwritten signature.

6. Click **“Apply”** after creating the signature.
7. Position the signature box where you want it on the document and click to place it. You can resize or move it as needed.
8. Save the signed PDF. Adobe automatically locks the signature to the file to deter tampering.

## Method B: Using Microsoft Word

1. Place your cursor where you want

- the signature line to appear in the Word document.
2. Go to the **Insert** tab, then click **“Signature Line”** in the Text group.
  3. Fill in the signer details (your own name and title). You can also allow the signer to add comments in the “Sign” dialog.
  4. Click OK – a signature line with an “X” will appear.
  5. Right-click the signature line and select **“Sign”**.
  6. In the Sign dialog, you can:
    - Type your name (Word creates a handwritten-style text).
    - Select a pre-created digital signature image.
    - Draw your signature if you have a touch device.
  7. Click **“Sign”** to affix the signature. The document becomes read-only once signed (if you use the digital signature feature).

## Method C: Using a Mobile

# App (Adobe Fill & Sign for iOS/Andro id)

1. Download and install the free Adobe Fill & Sign app from your app store.
2. Open the app and tap the camera icon to take a picture of the document, or tap the folder icon to import a PDF from your device or cloud storage.
3. Tap the **“Signature”** icon (a pen) at the bottom toolbar.
4. Choose to **“Create Signature”**. You can draw your signature with your finger, type it, or use the camera to capture a signature written on paper.
5. Once created, tap anywhere on the document to place the signature. You can drag and resize it.
6. Add the date or other fields as needed, then save or share the signed document.
