These formulations are not separate principles but different ways of expressing the same fundamental idea: morality is rooted in reason and respects the dignity of rational beings.

## Autonomy vs. Heteronomy

Kant contrasts **autonomy** (self-legislation) with **heteronomy** (being governed by external forces like desire, social pressure, or divine command). For Kant, a moral agent must be autonomous: the source of moral law lies in the rational will itself. Heteronomy reduces morality to a set of hypothetical commands, making it contingent on outcomes. This emphasis on autonomy is

revolutionary because it grounds moral authority within each rational being, not in external authorities.

### THE HISTORICAL AND PHILOSOPHICAL CONTEXT

**The Foundations of the Metaphysics of Morals** was written during the Enlightenment, an era that championed reason, individual rights, and progress.
